Context and barriers faced by the school

Wembrook Primary school is larger than most primary schools. The number of pupils who come from minority ethnic groups is broadly in line with the national picture. The proportion of pupils who speak English as an additional language is also broadly in line with national data.

The school catchment area covers a wide area comprising of council, housing association and privately owned houses.

The Index of Multiple Deprivation informs us that 25% of our pupils live in the highest 10% most deprived SOA's nationally, with 55% of our pupils living in the top 30% most deprived SOA's nationally (May 2019).

Barriers to future attainment (for pupils eligible for PPG)

Barriers

A.	A significant number of PPG children are weak in Cultural Capital. They lack experiences and overall knowledge
B.	The spoken word for a significant number of PPG is underdeveloped and grammatically incorrect.
C.	For some PPG pupils their emotional intelligence is significantly under developed
D.	Low attendance for some of the PPG children can be a continuing area of concern.
E.	A number of PPG families require or benefit from external help through either supportive initiatives, such as Triple Training and Adults in the Community work or more formal avenues such as Early Help or support from Social Care.
F.	Data suggest that PPG pupils joining the school at the beginning of their educational journey are not academically as developed as non PPG pupils.
